



Trickssi – Convention Rider

Please read this rider carefully. It is part of the attached contract for Trickssi, hereafter referred to as the "Artist". By signing it, you, hereafter referred to as the "Convention", agree to supply her with proper and safe working conditions essential to her participation. Any breach of the terms and conditions of this rider is a breach of contract and may cause Trickssi to refuse to participate with your event.

A. Advertising and Promotion

A1. Billing on all advertising and publicity will refer to the Artist as "Trickssi".

A2. Convention agrees to only use photos, artwork, and/or other promotional materials provided by and approved by the Artist and will credit the photographers where applicable.

A3. Convention agrees not to commit the Artist to any personal appearances, interviews, or other promotional appearances without prior written consent from the Artist or her representative.

A4. Convention agrees to make available two (2) complimentary badges available to the Artist for her and her handler.

B. Convention Safety

B1. Convention agrees to update their harassment policy (if needed) to meet the standards of the Cosplayer Survivor Support Network. These standards are:

B1a. The harassment policy must exist.

B1b. The harassment policy must be easy to find on the convention website, preferably linked to on the front page or website header.

B1c. The policy must define harassment.

B1d. The policy must define consequences for harassment.

B1e. The policy must explain what to do if staff are the offenders.

B1f. The policy must list contact information, such as a phone number or email.

B2. Convention agrees there shall be no discrimination for reasons of race, religion, gender, gender identity, sexual orientation, age, disability, national origin, or any other class prohibited by local, state, or federal law in connection with the sale of badges, admission, or accommodation at the event.

C. Hospitality, Accommodations, and Travel

C1. Convention agrees to provide hotel accommodations (if required) for the Artist and her handler for the duration of the convention.

C2. Convention agrees to reimburse the Artist for one (1) round-trip plane ticket (if required) and/or reimburse for mileage driven at the rate of \$.50 cents/mile driven to and from the convention. (2020 standard mileage rate is \$0.57/mile.

C3. Convention agrees to provide Artist with a per diem of \$30 for each day of the event that the Artist is required to attend, for the purchase of meals.

C4. Artist reserves the right to waive and/or modify any of these clauses if they would put undue financial hardship on the convention.

C5. Convention agrees to communicate with the Artist and/or her handler and give her at least two (2) hours' notice of any change of location, time, or requirements regarding any event where the Artist will be attending. Communication will be via text message.

D. Content

D1. The Artist agrees to provide the following content:

D1a. Ballroom dance lessons.

D1b. Accessible ballroom dance lessons.

D1c. Playlist for DJing a formal ball/dance.

D1d. Hosting for a formal ball/dance, including making announcements, leading line dances, creating a companion slide presentation to match the song list, and DJing the event.

D1e. Judging masquerade and/or dance performances.

D1f. Emceeding main events, including masquerades, formal balls/dances, opening/closing ceremonies, and/or Q&A sessions.

D1g. Hosting panels and workshops.

D1h. Showcase dance performances on a prepared state or floating floor.

D1i. VIP meet and greet.

E. Payment

E1. In the event the Convention fails to make any payment at the time previously agreed to, the Artist shall have the right to withhold their appearance/performance without prejudice.

E2. Payment will be made via cash, check, money order, or electronic funds transfer.

This Agreement shall be effective only when signed by the Convention and returned to the Artist.
